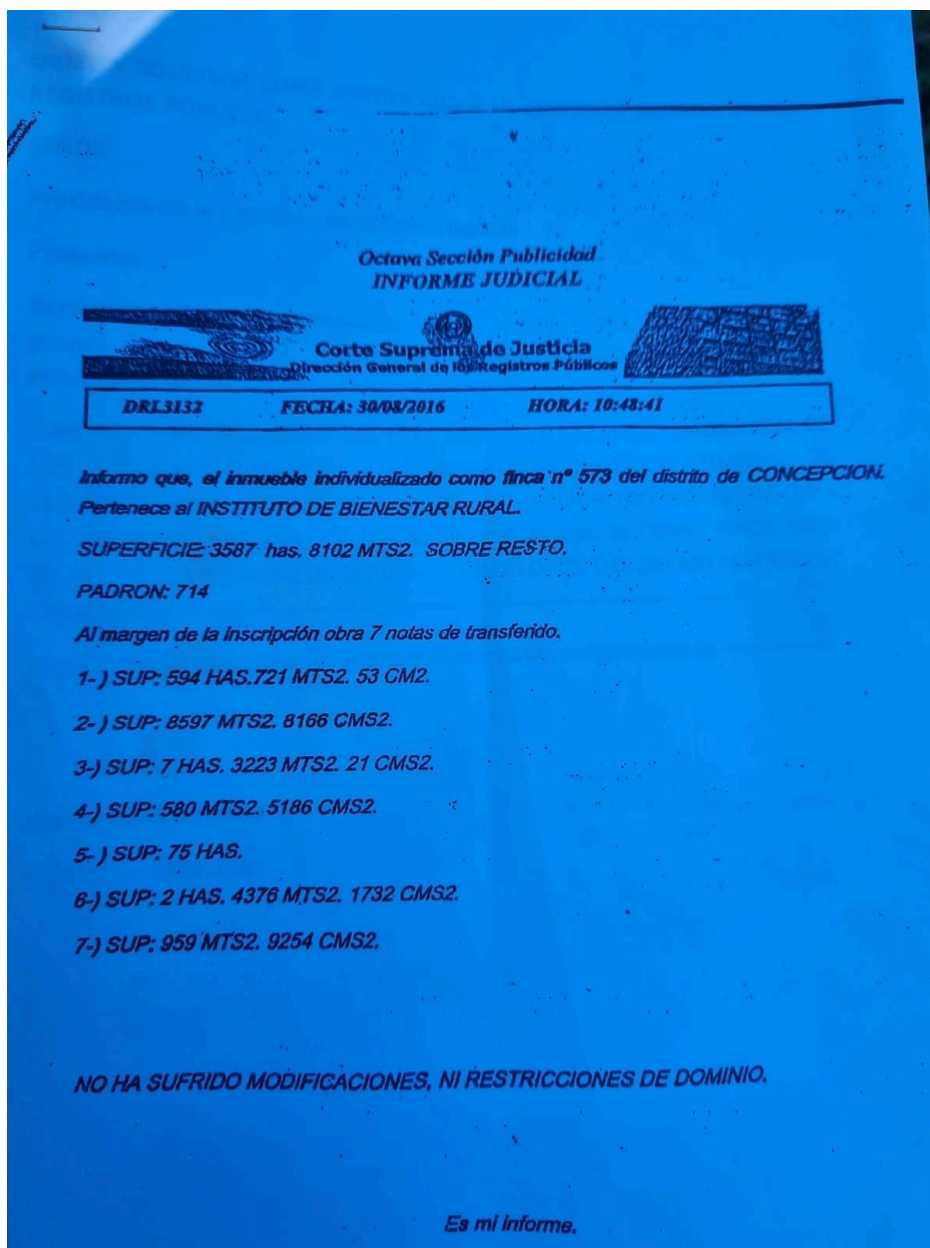

**Annex 1.** Address of Public Registries where no changes to the domain of Property No. 573 are registered and which belong to the former IBR, currently INDERT.



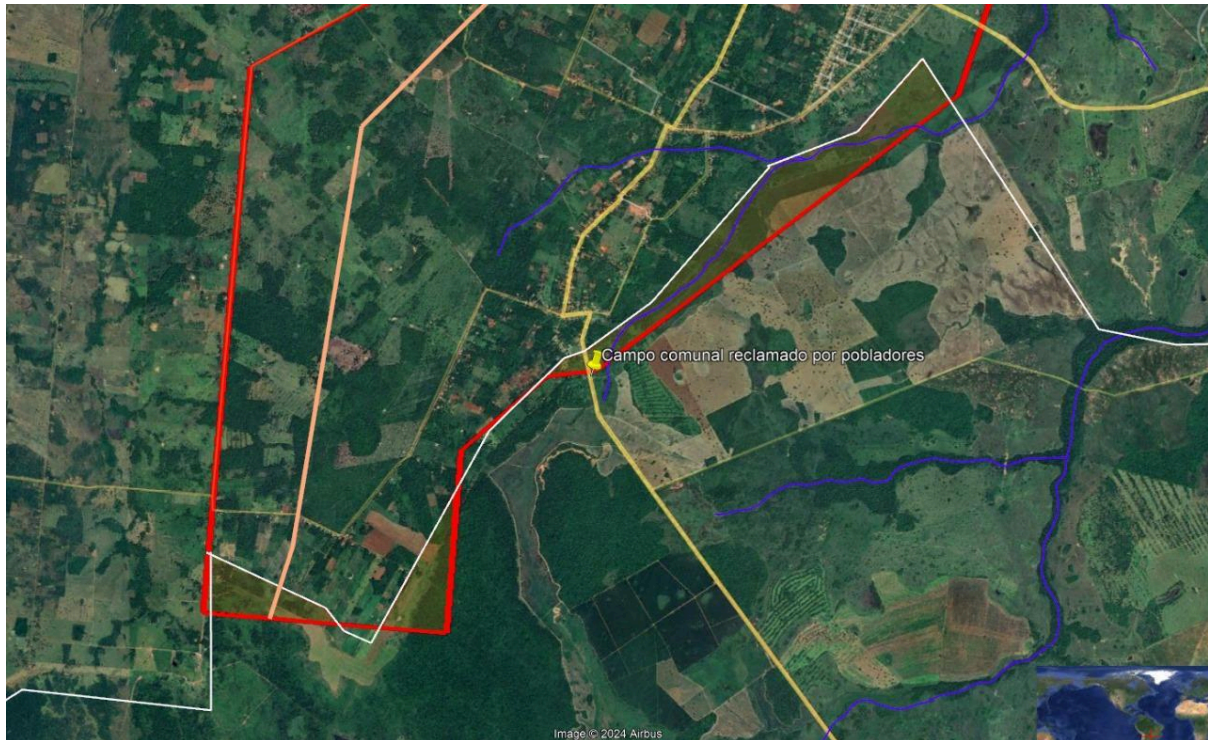
**Annex 1.1** Overlapp of Farm No. 22 belonging to PARACEL (from March to FINEXPAR) with an area of 15,178 hectares overlap on part of the lands of farm No. 537.

The reference point to locate the polygon of Farm No. 573 is where the Zanja Molina stream meets the Itagué Stream (according to the title) or Itaky (according to current toponymy), which

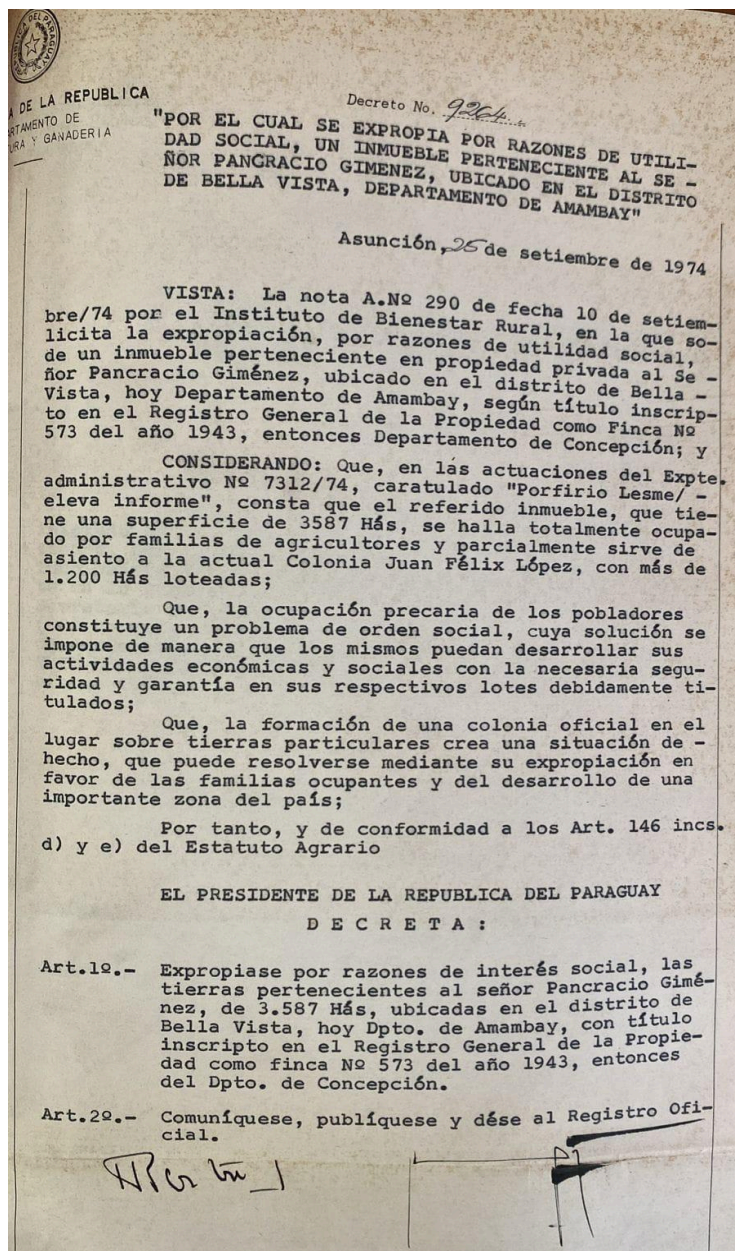
is located in the northeast corner of the property. From this point on, the northern boundary of the property is the Zanja Molina stream and the eastern boundary is the Itagué or Itaky stream.

In the red polygon, Property No. 573 of INDERT, in the white line polygon, Register No. 22 used by Parcel.

The area occupied by PARACEL, which belongs to property No. 537 of INDERT, is painted in transparent orange.
